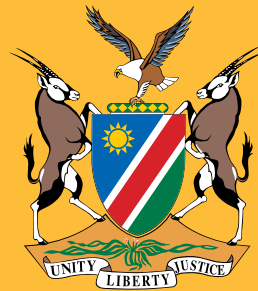

#### Business Management/Marketing

**Required Master's Degree in Business Management or Marketing.** A person with extensive experience in business or marketing of agro business products. Extensive knowledge in the agriculture industry. At least five (5) years' experience at senior management or executive level. Experience as a board member will be an added advantage.

#### Agronomist

**Required Master's Degree in crop science.** A person with Extensive knowledge in the agriculture industry and proven experience in irrigation farming will be an added advantage. At least five (5) years' experience at senior management or executive level. Experience as a board member will be an added advantage and proven experience.

#### Finance

**Required Bachelor's Degree in Accounting with a Chartered Accountant qualification or equivalent.** A person with financial management and accounting experience and preferably a registered chartered accountant.
